From the President

What a great year 2013 was for this, the Santa Barbara Trust for Historic Preservation's golden anniversary year! Ms. Pearl Chase and the other founders of the Trust would have been amazed and very pleased with the Trust's accomplishments over the last 50 years. We owe a deep debt of gratitude to all of the people who spent so much time and effort as staff, volunteers and members of the Board of Directors of the Trust. All of the programs, events, property acquisition, preservation and reconstruction could not have occurred without their hard work.

During 2013, the Trust celebrated its anniversary with many events. One of the highlights was its gala, *Un Paseo En Oro*, held at the historic El Paseo restaurant and put on so ably by event co-chairs Therese Chin and Keith J. Martino. I was privileged to be Master of Ceremonies and to introduce our special guests, M. Wayne Donaldson, Chairman of the National Advisory Council on Historic Preservation, and Enrique Ruiz Molero, Council General of Spain in Los Angeles. It was a great success both financially and from the standpoint of appropriately celebrating the Trust's anniversary.

Another highlight was the visit by crown Prince Felipe of Spain to Santa Barbara and the special reception the Trust held for him at the Biltmore. Given the Trust's role in helping to preserve Santa Barbara's Spanish heritage and the reconstruction of the Royal Presidio, it was a great honor to have the Prince spend his limited time with us. Not only was he very gracious, but he went out of his way to make sure he personally greeted all of the attendees. In addition to the Prince, we were honored with the presence of the Spanish Foreign Minister, the Spanish Ambassador to the United States and our friend, Council General Molero.

The Trust also marked the 300th anniversary of the birth of Father Junípero Serra with a Sunday service in the Presidio Chapel on November 24, 2013 and a trip to see the "Junípero Serra and the Legacies of the California Missions" exhibit at the Huntington Library. There was an informative article in the fall issue of La Campana by Norma Jungjohann on Father Serra which noted that the last founding mass Father Serra conducted was at the Santa Barbara Presidio in 1782. There was an excellent exhibit on Father Serra displayed by the Trust in the Casa de la Guerra.

The Trust is fortunate to have had, and continue to have, a strong relationship with the California Department of Parks and Recreation. In 2013, the Trust was honored with a personal visit by the new Director of State Parks, Major General Anthony Jackson. We were also fortunate to have Aaron Robertson, the new Second in Command at State Parks to attend the annual meeting and make a presentation to the membership.

The Trust's mission is to preserve, protect and restore historic buildings and sites in Santa Barbara County. In pursuit of that mission, the Trust has become the manager and owner of a significant amount of property. In 2013, there were a number of major events involving those properties. One of those was the sale of a residential property on Old Mill Road in Solvang. The proceeds of that sale were used to significantly reduce the debt the Trust had incurred to acquire the residence along with eight acress that complimented the Santa Ines Mill Property.


Another major event was the reopening of the cocktail lounge at Jimmy's Oriental Gardens, thereby restoring the historic use that was a favorite of many locals. During 2013 the Ensemble Theatre Group left the Alhecama Theatre and moved to its new location at the remodeled Victoria Street Theatre. This will give the Trust the opportunity to complete the renovation of the Alhecama Theatre facilities before it used by a new tenant and the Trust. The Trust is currently in active discussions with prospective users and looks forward to having a new tenant in a renovated facility during 2014.

A major restoration project was nearly completed in 2013: reconstruction of the western outer defense wall at the northwest corner. The Board decided that it was a priority to complete the wall as soon as possible and authorized use of unrestricted funds to make that happen. This led to a decision by the Major Gifts Committee to take on a much larger project, the 4x4x4 Campaign to raise \$4,000,000 in four years to complete archeological excavations, construct the defense wall through to Santa Barbara Street, create an education complex and install new visitor exhibits in the New Visitor Center, all to enhance visitors' experience at the Presidio.

From a financial standpoint, the Trust experienced a good year in 2013. Its endowment did well and contributed approximately \$280,000 of funds to pay for the Trust's operations. The Trust was also able to earn an additional \$15,000 for operations from its Lompoc properties. The Trust is on its way to earn income from the production, bottling and sale of olive oil from the Santa Ines property.

Trust to retire all of its debt and generate some funds for future operations. The Trust is anticipating the installation of exhibits in the New Visitor Center and at the bar at Jimmy's Oriental Gardens. It will continue its wonderful education programs such as the living history days at El Presidio and the Casa Camp.

It has been a real honor to serve as President during this past year and work with the Trust's dedicated volunteers, staff and Board of Directors. I hope that each of you will find time to make a contribution to the Trust and its activities during the coming year.

Committee the outer perimeter wall of the Presidio Northwest Corner

was completed by November—the wall contains 16,000 adobe bricks, all made on site and its completion is one of the legacies of our 50th Anniversary year.

In the ever-expanding universe of SBTHP we had a near bumper crop of olives this year at the Santa Inés Mission Mills property that were immediately crushed for oil and will fill 1,200 bottles in total. This oil is exquisite and meets the high standards we set for everything we do around SBTHP.



This coming year we will be focused on three main projects: park planning for the Santa Inés Mission Mills property, conversion of the Alhecama Theatre to a multi-purpose facility, and unleashing our 4x4x4 Campaign—raising four million dollars in four years to complete four projects—a final phase of archaeology, construction of the Presidio perimeter wall to Santa Barbara Street, installation of a state of the art museum exhibit in the Visitor Center and creation of a new Education Center. My special thanks go out to the Trust Board, Staff, California State Parks, our many supporters, and volunteers for Fifty Glorious Years.

El Presidio de Santa Bárbara State Historic Park & Business Affairs

The Santa Barbara Trust for Historic Preservation continues to partner with the State of California Department of Parks and Recreation in the reconstruction and management of El Presidio de Santa Bárbara State Historic Park. The unique partnership between these two organizations has resulted in a State Historic Park located right in downtown Santa Barbara, that operates at no cost to California taxpayers, yet provides high quality programming and visitor experiences that celebrate Santa Barbara's Hispanic and Asian heritage.

The daily operation of El Presidio SHP is funded by admission fees, as well as net rental income generated by commercial and residential properties located on State property. The annual operating budget for the State Park for fiscal year 2012-13 was over \$750,000, and continues to grow every year. SBTHP obtains grants and donations to fund reconstruction and restoration projects for portions of El Presidio, and interpretive programs and living history events such as Presidio Pastimes. Additionally, the SBTHP continues to develop the Santa Inés Mission Mills, located near Solvang, on behalf of State Parks.

Significant progress on the Presidio Northwest Corner reconstruction project this year has furthered implementation of the park's general plan. As dictated by the multi-year operating agreement between SBTHP and the State, any capital improvements funded by the Trust and by donations transfer, upon completion, to the State of California.



About 5,000 guests enjoyed SBTHP's annual summer fundraiser, Casa Cantina, this year, which has netted over \$300,000 in unrestricted income since its inception. SBTHP is pleased to continue its partnership with Plus One Events, and appreciates the contribution of dozens of volunteers to make this year's event a success.

Archaeology & Restoration

This year's primary focus was the reconstruction of the outer defense wall of the Presidio Northwest Corner, one of four components of SBTHP's new 4x4x4 Capital Campaign. Board Member Tim Aguilar supervised volunteers and a hired crew to make more than 7,500 adobe bricks towards the completion of the wall. Preservation planning this year included the rehabilitation of the Alhecama Theatre, which will involve restoring the original auditorium, a seismic retrofit, and constructing an ADA-compliant restroom, seating, and paths of travel. In addition, Harrison Design Associates and Studio Engineers are developing plans for the restoration of the façade of the Cota-Knox building.

Maintenance Supervisor Eduardo Garcia repaired portions of the Presidio NE Corner defense wall. He also repaired the adobe floor and installed a new willow stick fence at El Cuartel. Garcia supervised Santa Barbara County Probation Department workers as well as volunteers from Cate School, Anacapa School, and the United Way Day of Caring who whitewashed the Presidio Chapel. In October we installed a stabilized decomposed granite surface in the Casa de la Guerra courtyard.

Anacapa School students Neeva Pradhan and Pica Zhuang planted winter crops, built trellises, and made plant labels as interns in the Presidio Heritage Gardens. Volunteers Frank Arredondo, Jasmine Arredondo and Judy Sims interpreted the gardens, and staff and volunteers hosted the archaeology station during living history events. Volunteer Jeannie Davis created a new plaque to honor the work of the California Conservation Corps at the Presidio. Archaeologist Michael Imwalle continued to work with California State Parks Channel Coast District staff on projects at El Presidio de Santa Bárbara SHP, Chumash Painted Cave SHP, and at the Santa Inés Mission Mills.

It was an honor to celebrate SBTHP's 50th Anniversary with *Un Paeso en Oro* at the historic El Paseo on May 18, 2013. Co-chaired by Terease Chin and Keith Mautino, with honorary chairs Milford Wayne Donaldson and Marilyn Chandler DeYoung, the event brought together longtime friends and members. SBTHP is grateful to The Towbes Foundation, the highest sponsor, for funding many 50th anniversary projects. Additional event sponsors include Union Bank, the Montecito Bank & Trust, and the Santa Ynez Band of Chumash Indians.

In 2013 we planned the launch of our new 4 x 4 x 4 Campaign: \$4 million for four projects in four years. As we advance the Presidio Northwest Corner Project, we will conduct an archaeological excavation in the area to the rear of the Presidio's north wing. We are also in the advanced planning stages for a new Presidio Visitor Center and have begun planning for an Education Complex. Together these projects will reshape our visitor experience. The National Endowment for the Humanities and the Williams Corbett Foundation both supported the Visitor Center project in 2013. Generous gifts towards the Northwest Corner Reconstruction Project have also come from the Outhwaite Foundation and The Ann Jackson Family Foundation.

Commemorating Prince Felipe of Asturias's visit to Santa Barbara on November 15, 2013, Christa Clark Jones and Jeannie Davis created a plaque for the future Presidio Donor Wall, which will be named in his honor. We look forward to recognizing both old and new friends on the donor wall, which will remind future generations of the support the Presidio project has received from the community.



Historic Resources Division

The Historic Resources Division produced an array of beautiful exhibitions and advanced interpretive planning for El Presidio SHP this year. In February we opened "Junípero Serra in Mexico: Five Missions in the Sierra Gorda de Querétaro," a beautiful exhibit curated by Julianne Burton-Carbajal of photographs by Jeffrey Becom and drawings by Richard Perry at Casa de la Guerra. This exhibit was followed by successful collaboration with local photographer and filmmaker Shaw Leonard. An exhibit of Leonard's photographs, "Secrets of the Gaviota Coast," opened in early September. In May we created a series of interpretive panels featuring the history of El Paseo for SBTHP's 50th Gala, *Un Paseo en Oro.* We opened a new exhibit in December featuring the components of SBTHP's new 4x4x4 capital campaign, which is displayed in the Presidio's Northwest Corner.

We also finished the preliminary design phase of planning for the new Visitor Center at El Presidio SHP, a process that was begun with funding from the National Endowment for the Humanities in 2012. All of these projects were accomplished with the help of 2013's two talented Jim and Sue Higman Interns, Emma Engstrom and Mika Thornburg.

Presidio Research Center

The Presidio Research Center was accessed by a diverse set of research patrons in 2013. Appointments included students from California State University at Channel Islands and California Polytechnic University, Pomona who were interested in 19th century California, and faculty at Westmont College and University of Massachusetts at Boston interested in local Asian American history. We welcomed, among others, first-time visits from Quintero and Gonzales descendants, members of Presidio founding families interested in researching their ancestors.

Contract librarians Laurie Hannah and Lisa Marsh cataloged books, processed manuscript collections and completed cataloging and rehousing the maps and plans collection. Hannah rehoused and created a finding aid for the Sue Higman collection, which includes valuable material related to the Community Arts Association and the Plans and Planting Committee. Research Center Committee members conducted five interviews for SBTHP's oral history project.

Education

This year the Education Department continued its tradition of bringing meaningful events that explore and interpret local and state history. Some events reached out primarily to children, some to adults, but most were catered to families of all ages.

For families, SBTHP held Founding Day, Presidio Pastimes by Candlelight, Presidio Pastimes, the Santa Barbara Presidio's Asian American Neighborhood, and two holiday events, *Una Noche de las Posadas* and *La Pastorela*. For children, the department put on two living history programs for students, called Early California Days, as well as CASA (Cultural Arts and Summer Adventures) Camp, and *Dia de los Muertos* Craft Day. For adults in 2013, SBTHP hosted Sharing Our Common Ground: The 4th Annual Asian American Film Series as well as two lectures. The first lecture, presented by Dr. Amy Greenberg, centered on the 1846 U.S. invasion of Mexico as discussed in her book *The Wicked War*. Greenberg's lecture was followed by Spanish graduate student Mabel Isabel Cobo Hernando, who spoke about the history of the de la Guerra family in Northern Spain, before Don José immigrated to New Spain.

Volunteers, who are honored at our annual Volunteer Appreciation Luncheon, are essential to the success and sustainability of all of these programs. Committee members, especially those on the Education Committee and the Asian American History Advisory Committee, docents, *soldados*, plus volunteers who work at selected events, all help make these special programs possible.

Visitor Services & Rentals

After implementing new programs and social media outlets last year, this year the Visitor Services Department focused on continuing growth and enhancing our sites through a series of staff trainings, flyers and promotions, and regular postings on our social media accounts. As a result, we can report an increase in guided tours, visitor participation in various contests and activities, and support for upcoming projects. Visitor attendance has also remained consistent, with over 10,000 visitors to the Casa and Presidio and over thirty school and group tours.

Staff reorganized the gift shop, *La Tiendita*, in the effort to make it more appealing and simpler to navigate. We improved the presentation of flyers and other promotional materials, and updated the Docent Library. These projects allow weekend interpreters and front desk staff to be more efficient and therefore provide a better visitor experience.

Our department hosted another successful Veterans Day ceremony, as well as a Flag Day ceremony. We also coordinated of a tour of the "Junípero Serra and the Legacies of the California Missions" at the Huntington Library and Botanical Gardens and assisted with a special reception at the Biltmore Hotel for the Crown Prince of Spain during his visit to Santa Barbara in November.

Facility rentals continued to increase in 2013, with forty-five rentals occurring over four of our properties, twenty-nine of which were weddings or receptions. Other rentals included festivals, parties, and concerts.

Santa Inés Mission Mills

The wheel has turned another year at the Mills properties and I have been blessed to be close enough to hear the whispered lessons each rotation tells. 2013 was again a dry year but the lack of brush provided an opportunity to concentrate more time on park improvements and increased maintenance.

Mundane as the above may sound, this was also a year of success and accomplishment. Our olive groves produced our best crop ever. After harvest SBTHP milled slightly more than three tons of olives for a net of 122.5 gallons of high-grade olive oil. We immediately bottled an "olio nuovo" for our first time, in limited quantity, as a special holiday treat.



There were several group and private tours conducted of the historic site this year and Lot 72 was again rented for the SCOR bike ride and the Vintners' Festival.

The highlight of the year was the 3D scanning project conducted at the Mission Mills site by the EAST Initiative Class at Santa Ynez Valley Union High School. These gifted students used cutting-edge technology to produce a virtual model of the entire Mill Complex, inside and out, accurate to 1mm. Absolutely amazing!


